Community Stage Rules and Policies

- 1.) To participate in the PrideFest Broadway Community Stage, you must complete the application and return it BY JUNE 1st 2007 to:

- 2.) Preference will be given to those performances that indicate that they are a group production style performance.
- 3.) One representative from your group ***MUST*** attend a mandatory Community Stage meeting at The Center, 1050 Broadway. This meeting will cover line-up, performance schedules and additional rules and/or procedures.
- 4.) Any group failing to attend this meeting forfeits their participation on the PrideFest Broadway Community Stage.
- 5.) The amount of time and line-up positioning will be determined by the Broadway Community Stage Committee based on the type of activity that is anticipated.
- 6.) Performers must abide by the laws of the City and County of Denver and the State of Colorado. The Broadway Community Stage Committee and The Center and their Board of Directors reserve the right to stop ***ANY*** performance in process that is judged to not be in compliance with these laws.
- 7.) Performers under the age of 18 will need to have a parental/guardian release form (attached, please photocopy as needed) on file with the Broadway Community Stage Committee.
